As announced in “Disposal of Treasury Stock as Post-Vesting Allotment Type Stock-Based Compensation (FY2020 Second RSU)” dated June 29, 2022 (the “Press Release”) regarding the disposal of treasury stock for the FY2020 Second RSUs, which was resolved by the Company at its Board of Directors meeting held on June 28, 2022 (the “Treasury Stock Disposal”), the actual number of shares to be allotted has been finalized as a result of the vesting of the rights upon arrival of the vesting date, July 28, 2022. As a result, there have been changes in the number of shares to be disposed of, etc. as set out below.
