This patent license shall apply to the combination of the Contribution and the Program if, at the time the Contribution is added by the Contributor, such addition of the Contribution causes such combination to be covered by the Licensed Patents. - b) You must cause the files modified to carry prominent notices stating that you changed the files and the date of any change.
